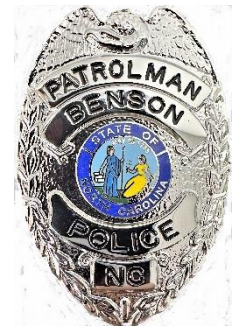


Acceptance Prerequisites:

Release of Liability - Participation in the Benson Police Department Citizen's Police Academy:

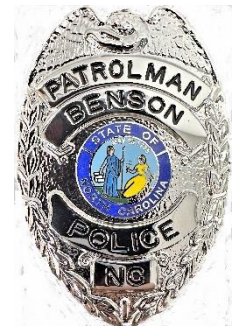

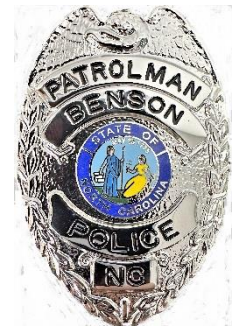
